Binod C. Agrawal, MSc, PhD, Wisconsin, is Director of the TALEEM Research Foundation, Ahmedabad. He worked for over two decades as Advisor at the Space Applications Centre, Indian Space Research Organisation (ISRO) where he pioneered the use of qualitative research methods for the Satellite Instructional Television Experiment (SITE) and led the SITE research and evaluation team. He is also the founding Director of the Mudra Institute of Communications, Ahmedabad (MICA), and of India's first professional teaching programme in business communication and advertising. He has lectured in universities in the United States and represented India in several international communication research forums. Recent publications include *Higher Education Through Television – The Indian Experience* (Concept Publishing 2000) and *Television in South Asia* (University Press of America forthcoming).

Peter S. Anderson is Director, Telematics Research Lab, Associate Director of the Centre for Policy Research on Science and Technology and Associate Professor of Communication at Simon Fraser University, Canada. His background is in the fields of telecom, media and information systems policy. He participates in the design and implementation of electronic communication and information systems for disaster management in collaboration with the United Nations, and scientific, government and non-government disaster management organisations and firms. He is the author of many publications and studies on communication policy, networking and planning. Professor Anderson also teaches accredited courses and supervises graduate research in emergency communication.

Dr Ang, Peng Hua is a member of the Singapore Bar and Vice-Dean of the School of Communication and Information. He teaches and researches media and Internet law and policy. He has presented before and consulted for governmental, international and non-profit agencies on Internet-related legal issues in Singapore, Australia, Canada, Malaysia, Mongolia, the Philippines, South Korea, the United States, Belgium and Germany. He is a Board member of the Internet Content Rating Association, which is working to create an international standard for content self-labelling for the Internet. In 2000 and 2001, he spent a sabbatical at Harvard University and Oxford University.

Jens C. Ambak completed graduate engineering studies in 1968 and PhD studies in 1970. He worked for eight years as an international civil servant in The Hague in support of satellite and other digital networks for joint political decision making by NATO countries. He was appointed Professor of Wireless Communications at Eindhoven University of Technology in 1979. Since 1986, he has held the chair of Tele-information Techniques at the Delft University of Technology, where he also held a part-time chair in the School of Systems Engineering and Policy Analysis from 1994 to 1997. He was appointed chairman of OPTA, the independent Dutch National Regulatory Authority in 1997, and is a board member of the Dutch Engineering Academy (NFTW). He is currently listed in *Who's Who in Engineering*.

Robert E. Babe holds the Jean Monty/Bell Canada Enterprise Chair in Media Studies, Faculty of Information and Media Studies at the University of Western Ontario, Canada. Since completing his PhD in Economics at Michigan State University, he has taught at several universities in both economics and communication departments, and has consulted widely on communication matters, appearing as an expert witness before Canadian tribunals. He is author or co-author of many books, including *Communication and the Transformation of Economics* (Westview Press 1995), *Canadian Communication Thought* (University of Toronto Press 2000) and *Cultural Ecology: Communication, Environment and Development* (University of Toronto Press 2002 forthcoming), and editor of *Information and Communication in Economics* (Kluwer 1994). In 1999, he received the Ontario Confederation of University Faculty Associations (OCUFA) Award for Outstanding University Teaching.

Johannes M. Bauer is Associate Professor in the Department of Telecommunication at Michigan State University where he also serves as the Associate Director of the James H. and Mary B. Quello Center for Telecommunications Management and Law. He joined Michigan State University in 1990 after receiving his PhD in economics from the Vienna University of Economics and Business Administration. From 1993 to 1998 he directed the Institute of Public Utilities and Network Industries at the Eli Broad Graduate School of Management, Michigan State University. He has published widely on issues of regulatory reform in telecom and energy policy, and is author or editor of five books, including *Walking a Thin Line in Infrastructures: Balancing Short Term Goals and Long Term Nature* (Delft University Press 2001) and *Telecommunication Politics: Ownership and Control of the Information Highway in Developing Countries* (Lawrence Erlbaum Associates 1995).

Dr Jörg Becker is Honorary Professor of Political Science at Marburg University and Managing Director of the KomTech Institute for Communication and Technology Research in Germany. His work focuses on international and comparative media, and culture and technology policy. His recent publications include *Internet in Asia* (Singapore: AMIC 2001), *Internet in Malaysia*, (Bangi: University Kebangsaan Malaysia 2001), *Information und Gesellschaft* (Vienna: Springer 2002) and *Communication and Conflict* (New Delhi: Concept 2002 forthcoming).

Dr Jean-Claude Burgelman is principal scientist at the Institute for Prospective Technological Studies (IPTS), which forms part of the Joint Research Centre of the European Commission. Formerly, he was Professor and Director of the Studies on Media Information and Telecommunications (SMIT) research centre at the Free University of Brussels, where he obtained his PhD in 1986. He has worked as Professor in Communication Technology and International Communications, and as Visiting Professor at the University of South Africa. His research focuses on the socio-economic and regulatory aspects of information and communication technology policy in Europe.

Martin Cave is Professor and Director of the Centre for Management under Regulation at Warwick Business School, University of Warwick, where he specialises in competition law and policy, regulatory economics, and telecom. Previously, he was Professor and Vice Principal at Brunel University, West London. He is an advisor to the Office of Telecommunications and a member of the Competition Commission in the United Kingdom. He has undertaken a review of spectrum management policy for the UK government. He is editor of the *Handbook of Telecommunications Economics* (Elsevier Science BV, forthcoming) and has published numerous articles in the *Economic Journal*, *European Economic Review*, *Information Economics and Policy*, and the *Oxford Review of Economic Policy*.

Cho, Sung Woon is a senior research fellow at the KISDI (Korea Information Society Development Institute), Kwachun, South Korea. He received his BA and MA from the Department of Mass Communication at Yonsei University, Seoul and PhD from the Department of Communication at the Ohio State University. His current research interests include the metamorphosis of the media industry in the Internet age and the consequences of communication technologies from the perspectives of political economy. He is author of *The Dynamics of Institutional Reform in Telecommunications: Globalization, Liberalization and Regulatory Change* (Garland Publishing 1998) and *Understanding Webcasting* (Nanam Publishing 2001).

Dr Edward Comor is an Associate Professor in the School of International Service at the American University, Washington DC. He is the co-founder and former Chair of the International Communication Section of the International Studies Association. He is the author of *Communication, Commerce and Power* (Macmillan and St. Martin's Press 1998) and editor/contributor to *The Global Political Economy of Communication* (Macmillan and St. Martin's Press 1994). He has published papers in numerous academic journals, including *International Studies Quarterly*, *Global Governance*, and the *Journal of Economic Issues*. His research focuses on political, economic and sociological structures and processes related to capitalism and globalisation.

James Cornford is a Principal Research Associate at the University of Newcastle's Centre for Urban and Regional Development Studies (CURDS). His primary interests are in the regional development implications of technological and regulatory change and economic restructuring in the audio-visual and telecom industries and the application of communication technologies in large public organisations. He has carried out a wide range of academic and consultancy activities for a range of sponsors including the ESRC, the European Commission, the OECD, as well as local authorities, development agencies and private organisations. He is co-author of *Putting the University Online* (Open University Press, forthcoming).

Dr James A. Dewar is a senior mathematician and Director of Research Quality Assurance at RAND. He is also Director of the Frederick S. Pardee Center for Longer Range Global Policy and the Future Human Condition and Frederick S. Pardee Professor of Long-Term Policy Analysis at the RAND Graduate School. For the past 15 years, his main research interest has been strategic planning. He led the development and application of Assumption-Based Planning (ABP), a tool for reducing avoidable surprises in planning and has a forthcoming book on ABP (Cambridge University Press). His planning experiences range from projects for all four military services, higher education institutions, public corporations and Fortune 100 companies.

John D. H. Downing is the John T. Jones, Jr Centennial Professor of Communication in the Radio-Television-Film Department of the University of Texas, Austin. He is author of *Internationalizing Media Theory* (Sage 1996) and *Radical Media* (Sage, 2001). He is working with C. Husband on *Representing 'Race'*, a comparative study of media, racism and ethnicity, and is editor of the forthcoming Sage *Handbook of Media Studies* and the Sage *Encyclopaedia of Alternative Media*. He teaches courses including media theory, alternative media and social movements, and non-western cinemas.

Elizabeth Fox is Senior Advisor at the Global Health Bureau of USAID. She has published extensively on Latin American media and politics, including *Media and Politics in Latin America: The Struggle for Democracy* (Sage and G. Gili, Spanish edition 1988), where she brought together Latin American scholars to examine the relationship between media and the political turmoil that had engulfed the region. In 1997 she published a book on the relationship between Latin American broadcasting and the United States government and industry, weighing the relative importance of domestic and foreign influences, *Latin American Broadcasting: From Tango to Telenovela* (University of Luton Press 1997). She has co-edited a book with Silvio Waisbord, *Latin Politics: Global Media* (University of Texas Press 2002).

Christopher Freeman is Emeritus Professor at SPRU – Science and Technology Policy Research at the University of Sussex, which he founded, then directed from 1966 to 1981. He was Visiting Professor at the University of Maastricht in The Netherlands from 1986 to 1996. His research interests focus on the relationship between technological and social change. He is the author of numerous books, including, with F. Louça, *As Time Goes By: From the Industrial Revolutions to the Information Revolution* (Oxford University Press 2001) and, with L. Soete, *The Economics of Industrial Innovation* (Pinter 1997).

David Gabel is a Professor of Economics at the City University of New York and a Visiting Scholar at the Massachusetts Institute of Technology Internet and Telecommunications Convergence Consortium. His area of specialisation is the telecom industry. He has focused on the evolution of telecom during the first competitive era of telephony (1894-1913) and on current developments in telephony. His recent studies focus on the pricing of interconnection in network industries, the cost structure of the telecom industry, retail pricing of network services under conditions of rivalry, and the deployment of advanced telecom services. His work has appeared in journals including the *Journal of Economic History*; *Harvard Journal of Law and Technology*; *Journal of Regulatory Economics, Law and Policy*; *Federal Communications Law Journal* and *Telecommunications Policy*. He is co-editor of *Opening Networks to Competition: the Regulation and Pricing of Access* (Kluwer 1998).

Oscar H. Gandy, Jr is the Herbert I. Schiller Information and Society Professor at the Annenberg School for Communication at the University of Pennsylvania. He is author of *The Panoptic Sort* (Westview Press 1993) and *Beyond Agenda Setting* (Ablex Publishing 1982), two books that explore issues of information and public policy. A recent book, *Communication and Race* (Edward Arnold and Oxford

University Press 1998), explores the structure of media and society, as well as the cognitive structures that reflect and are reproduced through media use. A book in progress, *If It Weren't for Bad Luck*, examines the ways in which probability and its representation affect the lives of different groups in society.

Nicholas Garnham is Professor of Media Studies at the University of Westminster. He has been an editor of *Media, Culture and Society* since its foundation in 1978. He is the author of *Capitalism and Communication* (Sage 1990) and *Emancipation, Modernity and the Media* (Oxford University Press, 2000). He directed the ESRC PICT Centre at Westminster from 1985 to 1995 and is a major contributor to debates in the fields of cultural and 'Information Society' policy.

Alison Gillwald serves on the South African Minister of Communications' African Advisors Group, chairs the Minister's Digital Broadcasting Advisory Body, and is a member of the Steering Committee of the International Telecommunication Union Task Force on Gender Issues. She is currently the director of the Learning Information Networking and Knowledge (LINK) Centre at the Graduate School of Public and Development Management at the University of the Witwatersrand, Johannesburg, South Africa. Prior to that she was appointed to the founding Council of the South African Telecommunications Regulatory Authority (SATRA). Before joining SATRA in 1997, Alison was responsible for establishing the Policy Department at the Independent Broadcasting Authority. She worked as a lecturer in journalism and politics for several years and as a journalist on some of South Africa's major newspapers.

John B. Goddard is Deputy Vice-Chancellor and Professor of Regional Development Studies at Newcastle University. He founded the Centre for Urban and Regional Development Studies (CURDS) in 1977 and led one of the research centres within the ESRC's PICT, which focussed on the geography of the information economy. He subsequently contributed to a project in the ESRC Virtual Society? programme on 'space place and the virtual university'. As Deputy Vice-Chancellor, he is responsible for the management of information systems and the university's regional policies. He has acted as adviser to the OECD's Institutional Management in Higher Education programme, the Finnish Higher Evaluation Council and the Higher Education Funding Council for England.

Dr Anders Henten is Associate Professor at the Center for Tele-Information (CTI), Technical University of Denmark. He is a graduate in communications and international development studies, Roskilde University, Denmark and holds a PhD from the Technical University of Denmark. His main areas of research are the

socio-economic implications of information and communication technologies including e-commerce and business models, internationalisation of services, and communication regulation. He has participated in numerous research projects financed by the European Commission, Danish Research councils and ministries. He has published more than a hundred academic publications in international journals, books, anthologies and conference proceedings.

John W. Houghton has a PhD in Economics from the University of Queensland, Australia. He has held positions as Senior Research Fellow at the Centre for International Research on Communication and Information Technologies (CIRCIT); Principal Economist at the Bureau of Industry Economics (BIE); Adviser, Information Industries Policy at the Australian Commonwealth Department of Industry, Science and Tourism; Principal Adviser, State Development Policy with the Victoria Department of State Development; and Associate Director of the Australian Expert Group on Industry Studies, University of Western Sydney. He is currently Professorial Fellow at Victoria University's Centre for Strategic Economic Studies (CSES) and Director of the Centre's Information Technologies and the Information Economy Programme. He has had a number of years experience in information technology policy, science and technology policy, and more general industrial and policy-related economic research.

Heather E. Hudson is Professor and Director of the Telecommunications Management and Policy Program in the School of Business and Management, University of San Francisco. She was previously Director of the New Technologies Area in the College of Communication at the University of Texas at Austin and Director of Telecommunications Applications for the Academy for Educational Development in Washington, DC. Dr Hudson received her BA (Hons) in English from the University of British Columbia, MA and PhD in Communication Research from Stanford University, and JD from the University of Texas, Austin. She has consulted widely on telecom and development issues, and has planned and evaluated telecom projects in more than 30 countries. She is author of numerous articles and conference papers, as well as several books including *Global Connections: International Telecommunications Infrastructure and Policy* (Wiley 1997), *Communication Satellites: Their Development and Impact* (Free Press 1990) and *When Telephones Reach the Village* (Ablex 1984). She is co-author of *Rural America in the Information Age* (University Press of America 1989) and *Electronic Byways: State Policies for Rural Development through Telecommunications* (Aspen Institute 1995).

Dr Meheroo Jussawalla is an Emeritus Senior Fellow/Economist at the East West Center in Honolulu Hawaii and Affiliate Faculty in the Department of Economics and of the School of Communications in the University of Hawaii. She is a leading scholar in the field of the Economics of Telecommunications and Development and her research focuses on the emerging economies of the Asia Pacific region. She is widely published with 13 books and many articles in accredited journals. She is on the Editorial Board of *Telecommunications Policy*, and the *Information Economics and Policy Journal*. She has served on the Board of Directors of the International Institute of Communication, London and is on the Board of Trustees of the Pacific Telecommunications Council. A festschrift was published in her honour, *Communications and Trade: Essays in Honor of Meheroo Jussawalla*, D. M. Lamberton (ed) (Hampton Press 1988).

Dr Tim Kelly is Head of the Strategy and Policy Unit of the International Telecommunication Union (ITU), where he has worked since 1993. Before joining ITU he spent five years as a Communication Policy Analyst with the OECD and three years with Logica Consultancy Ltd. He has an MA (Hons) in Geography and a PhD in industrial economics from Cambridge University. Over the last eighteen years, Dr Kelly has specialised in the economics of the telecom industry. He has written or co-authored more than 20 books and reports on the subject including the ITU's *World Telecommunication Development Report* (1998), *Direction of Traffic* (1999), *African Telecommunication Indicators* (2001) and *ITU Internet Reports: IP Telephony 2001*.

Dr Rolf W. Künneke is Associate Professor in the Faculty of Technology and Management, Delft University of Technology. He was a visiting Research Fellow at Auburn University in the United States and an Assistant Professor for over 10 years in the Faculty of Public Administration and Public Policy in the University of Twente, The Netherlands, where he completed his PhD in 1991. His research focuses on the privatisation of public utilities, particularly in the energy industry.

John Langdale is Senior Lecturer in Economic Geography at Macquarie University with research and teaching interests in economic restructuring and in the impact of telecom services on the economy. His research projects examine the growth of electronic trading in the foreign exchange market and the role of multinational companies in the Australian economy. He has published extensively in international academic and policy journals and has undertaken consultancies for Australian government departments, telecom carriers and private firms.

Amy Mahan is a researcher in the Economics of Infrastructure Programme at Delft University of Technology (TU Delft) in The Netherlands. She has served as production editor and co-book review editor for the international journal *Telecommunications Policy*. She is co-author of *Global Media Governance: A Beginner's Guide* (Rowman and Littlefield 2002). During the past decade she has lived and worked in Canada – Centre for Policy Research on Science and Technology (CPOST), Simon Fraser University; Australia – Centre for International Research on Communication and Information Technology (CIRCIT); and Ecuador (private consultant). She has an MA from the School of Communication, Simon Fraser University; and a BA from McGill University, Canada.

Dr Carleen F. Maitland is Assistant Professor in the Information and Communication Technologies Group, Faculty of Technology, Policy and Management at Delft University of Technology (TU Delft). She received her PhD in the Economics of Infrastructure Section at TU Delft. Her dissertation explored the influences of institutions on firm behaviour, focusing on the issue of e-commerce in developing countries. Her research focuses on changing market structures in the mobile/wireless communication industry. Before coming to Delft, she was in the Mass Media PhD programme in the Department of Telecommunication at Michigan State University. She has also held positions in a variety of firms in the telecom industry and holds a BSc in Electrical Engineering and an MSc in Engineering Economics from Stanford University.

Robin Mansell holds the Dixons Chair in New Media and the Internet at the London School of Economics and Political Science where she works with Media@lse (Interdepartmental Programme in Media and Communications) and convenes an MSc in New Media, Information and Society. From 1988 to 2000, she was Professor of Information and Communication Technology Policy at SPRU – Science and Technology Policy Research, University of Sussex. She received a PhD (1984) and MA (1980) from Simon Fraser University, Canada where William Melody was her supervisor. She also has an MSc (1976) London School of Economics and a BA (Hons) (1974), University of Manitoba, Canada. She has held positions as research associate with W.H. Melody & Associates (1984-5) and the ESRC PICT (1985-6), and as Administrator OECD (1986-7). She has consulted with many governments, inter-governmental organisations, and firms. Her research focuses on the social and economic implications of information and communication technologies and the development of policy in the communication field. Author of many books and articles her most recent works are: *Inside the Communication Revolution: Evolving Patterns of Social and Technical Interaction* (Oxford University Press, editor/contributor 2002); *Mobilizing the Information*

Society: Strategies for Growth and Opportunity (Oxford University Press, with W. E. Steinmueller, 2000; 2002), and *Knowledge Societies: Information Technology for Sustainable Development* (Oxford University Press, editor/contributor with U. Wehn for the United Nations 1988).

Dr Werner A. Meier is a lecturer and senior researcher at the Department of Mass Communication at the University of Zurich, Switzerland, and has been working independently as Media Policy Adviser to public bodies since 1986. He is a member of the Euromedia Research Group and has published extensively on media policy and economic aspects of mass media.

Ian Miles is Professor of Technological Innovation and Social Change at the University of Manchester, and CoDirector of PREST (Policy Research on Engineering, Science and Technology) and of CRIC (Centre for Research on Innovation and Competition), both at the University of Manchester. Before moving to Manchester in 1990, he spent almost twenty years at SPRU – Science and Technology Policy Research, University of Sussex. His main research interests include innovation studies, especially with respect to services innovation; social aspects of information technology, especially with respect to working life and new consumer products; social indicators, and technology foresight, and futures studies more generally.

Bella Mody is Professor of Telecommunication in the College of Communication at Michigan State University. A former advertising writer, Mody also has worked at Stanford University, San Francisco State University and for the Government of India. Her research focuses on the political economy of the media, and the design and evaluation of development-oriented policies and programmes. She is author of *Designing Messages for Development Communication* (Sage 1991) and co-editor of *Telecommunication Politics* (Erlbaum 1995) and the *Handbook of International and Intercultural Communication* (Sage, 2001). She also edited the Policy and Regulation section in L. Lievrouw and S. Livingstone (eds) *The Handbook of New Media* (Sage 2002).

Vincent Mosco holds a PhD from Harvard University and is Professor of Communication with joint appointments in Sociology and Political Economy at Carleton University, Canada. He is the author of four books and editor or co-editor of eight books on the mass media, telecom, computers and information technology. His most recent books are *Continental Order? Integrating North America for Cybercapitalism* edited with Dan Schiller (Rowman and Littlefield 2001) and *The Political Economy of Communication: Rethinking and Renewal*

(Sage 1996 with Chinese, Korean and Spanish language editions). He has also published over one hundred journal articles, book chapters and reports. He is working on a project that addresses the social and cultural consequences of high tech development and is writing a book on *Myths of Cyberspace*.

Edwin B. Parker is President of Parker Telecommunications. He is a former Professor of Communication at Stanford University, where he specialised in the social and economic effects of information technology. The second edition of his latest book, *Electronic Byways: State Policies for Rural Development through Telecommunications*, was published by the Aspen Institute in 1995.

Aileen Amarandos Pisciotta is a telecom partner in the Washington, DC office of the law firm of Kelley Drye & Warren LLP. Prior to this, she was Chief of the Planning and Negotiations Division of the International Bureau of the Federal Communications Commission, where she directed analyses of world-wide developments in telecom privatisation, liberalisation, corporate alliances and new technology. She is chair of the Electronic Commerce Task Force of the American Bar Association Section of International Law and Practice, and past chair of that Section's Public International Law Division, Business Transactions and Disputes Division, and International Communications Committee. She graduated *cum laude* from Georgetown University Law Center in 1983. She received an MA in 1977 from the Annenberg School for Communications at the University of Pennsylvania. She is listed in Law Business Research's *International Who's Who of Telecoms Lawyers 1999* and *2001*, as well as Strathmore's *Who's Who 1999* and *2000* and *Global Counsel 3000* (2000 and 2001 Editions).

Paschal Preston is Professor of Communication and Director of the Communication, Technology and Culture (COMTEC) research centre, Dublin City University. Following his PhD at the University of Reading, he was Research Associate with the ESRC PICT, London. His main research interests include political economy models and the regulation of communication services; the socio-cultural implications of new information and communication technologies; production, regulation and consumption aspects of digital media content and the cultural industries. He is author of *Reshaping Communications: Technology, Information and Social Change* (Sage 2001).

Marc Raboy is full Professor and Head of the Communication Policy Research Laboratory in the Department of Communication, University of Montréal, Québec. He has worked as a journalist in various Canadian print and broadcast media. He is the author or editor of thirteen books and more than one hundred

journal articles and book chapters, as well as research reports for national and international, public and private sector organisations including UNESCO, the Japan Broadcasting Corporation, the Council of Europe, the Policy Research Secretariat of the Government of Canada and the Quebec Ministry for Culture and Communication. In 2002 he was expert advisor to a parliamentary committee studying the present and future state of the Canadian broadcasting system.

Rivka Ribak holds a PhD from the University of California, San Diego (1993) and is Lecturer at the Department of Communication at the University of Haifa, Israel. Her work concerns the ways in which communication technologies mediate individual and collective identity, and she is currently involved in a project focusing on the introduction of the Internet into the domestic sphere. Liora Salter is a Fellow of the Royal Society of Canada and Professor at York University, where she teaches at Osgoode Hall Law School and in the Faculty of Environmental Studies. Rohan Samarajiva is Director of External Programs of LIRNE.NET (a learning initiative of the Technical University of Denmark and the Delft University of Technology), Visiting Professor of Economics of Infrastructure at TU Delft, and Senior International Specialist at the National Regulatory Research Institute in the United States. He is part of the management team of the World Dialogue on Regulation for Network Economies (www.regulateonline.org), headed by William Melody. He previously served in Sri Lanka as Director General of the Telecommunications Regulatory Commission and in the United States as Associate Professor of Communication and Public Policy at the Ohio State University. He has provided expert assistance to government authorities, regulatory agencies and consumer and citizen groups in Australia, Bhutan, Canada, India, Mexico, Morocco, South Africa and several American states. He obtained a PhD from Simon Fraser University, Canada, where his supervisor was William Melody.

Roderick Sanatan is Manager, Research and Development, at the Centre for International Services, University of the West Indies, Barbados. He spent the last fifteen years working on telecom policy for the Caribbean region, in the regional trade and governmental body, CARICOM; the last five years of that tenure were spent as Secretary General of the Caribbean Telecommunications Union, the intergovernmental regional organisation for telecom policy in the Caribbean. He has undertaken research and studies in the Caribbean and Latin America, and has represented the Caribbean at major international forums in Europe and the Americas. He has published several articles in journals and conferences on telecom and information and communication technology policy and regulation.

B. P. Sanjay is Professor and has taught communication at the Sarojini Naidu School of Performing Arts, Fine Arts and Communication, Hyderabad Central University, Hyderabad, India since 1995, after teaching at the Universities of Madras and Tirunelveli. He completed his graduate studies at Bangalore University where he had the opportunity to conduct research on the Satellite Instructional Television Experiment (SITE), 1975-76. After teaching at the University of Madras he completed his PhD at Simon Fraser University, Canada. His research focused on institutional relations in the transfer of an advance communication technology, the Indian National Satellite System (INSAT).

Peter Sheehan is Professor and the Founding Director of the Centre for Strategic Economic Studies at Victoria University, Australia. He obtained his PhD from Oxford, and has held academic positions at the Australian National University and the University of Melbourne, including Principal Research Fellow at the Institute of Applied Economic and Social Research. He was Director General of the Department of Management and Budget from 1982 to 1990, and was the author of numerous government reports and statements. He has published eight books and some thirty papers. His most recent books include (with L. Xue and F. Sun) *China's Future and the Knowledge Economy* (Victoria University Press and Tsinghua University Beijing forthcoming) and *Work Rich, Work Poor: Inequality and Economic Change in Australia* (Victoria University 2001).

Dr Peter Shields is Associate Professor of Telecommunications at Bowling Green State University. He received his PhD in Communication from Ohio State University. His teaching and research focus on telecom policy and regulation, information technology and privacy, social theory and emerging media, and national security and telecom. His work has appeared in *Telecommunications Policy; Media, Culture and Society; the Gazette; The Information Society; the Policy Studies Journal; Communication Theory*, the *European Journal of Communication, Journal of Communication; Media Development* and *Media International Australia*. He is co-editor of *International Satellite Broadcasting in South Asia: Political, Economic and Cultural Implications* (University Press of America 1998).

Roger Silverstone is Professor of Media and Communications at the London School of Economics and Political Science, where he directs Media@lse (Interdepartmental Programme in Media and Communications) and Chairs the Department of Sociology. He has taught at Brunel University and the University of Sussex, where he was Professor of Media Studies. He has researched and written widely in the field, most recently, as author, *Television and Everyday Life* (1994) and *Why Study the Media?* (1999). His research focuses on empirical studies of diasporic media in Europe, issues of media and community, and globalisation and alternative media spaces. He also examines representational ethics and media, new media and morality. His book project, *Screen Deep: Media, Ethics and Everyday Life* will bring these two strands of work together.

Supriya Singh is Associate Professor and Senior Research Fellow at the Centre for International Research on Communication and Information Technologies (CIRCIT), Royal Melbourne Institute of Technology (RMIT University), Australia. She holds a PhD in Sociology and Anthropology from La Trobe University, Melbourne. Her work concentrates on the use and design of information and communication services from the users' perspective. She is Vice-Chair of the Conference Committee (2002) for the Pacific Telecommunications Conference and heads its socio-economic track. She is also a member of the international advisory board of *New Media and Society* and President-elect of the International Association for Qualitative Research (AQR). Her most recent books include *Marriage Money: The Social Shaping of Money in Marriage and Banking* (Allen & Unwin 1994) and *The Bankers* (Allen & Unwin 1991).

Knud Erik Skouby is Professor and Founding Director of the Center for Tele-Information (CTI) at the Technical University of Denmark. Since 1986, his research has focused on technological planning, development and assessment,

particularly in the telecom industry. He has participated in and managed a number of national and international projects specifically related to the development and impact of new telecom services and infrastructures, and has been appointed to a number of government and professional committees, including the European Union's Economic and Social Committee (1994-98), serving on the sub-committee for EU legislation on information and communication technology-related matters. He has participated in the development of training programmes for developing countries and was a member of the Technical Programme Committee for International Telecommunication Union's Telecom '99 Forum. He is a member of the management teams of both LIRNE.NET and the World Dialogue on Regulation for Network Economies, each headed by William Melody.

Anthony Smith, CBE, has been President of Magdalen College, Oxford since 1988. During the 1960s, he worked as a television producer of current affairs programmes for the BBC, and was responsible for the key nightly news programme, *Twenty-four Hours*. In the early 1970s, he was Research Fellow at St Antony's College, Oxford, and worked for the Annan Committee on The Future of Broadcasting. He was deeply engaged in the national debate which led to the founding of Channel Four Television, and subsequently, was appointed a Board Director of Channel Four (1981-85). He carried out research for the McGregor Commission on the Press in 1976 and was Director of the British Film Institute from 1979 to 1988. He has written extensively on broadcasting and the Press, and on the modern information industries in general, including *The Oxford International History of Television* (Oxford University Press 1995; 1998) and *Software for the Self – Culture and Technology* (Faber & Faber 1996).

Ricardo Tavares is Research Associate at the Center for Economics of Telecommunications in Latin America (CELAET) and Senior Director of international operations at Wireless Facilities, Inc (WFI). He obtained his MA at the Rio de Janeiro University Research Institute and is currently pursuing a doctorate at the University of California, San Diego. After working for ten years as a journalist, he spent four years as editor and senior researcher at the Rio de Janeiro Federation of Organizations for Educational and Social Assistance. In 1993, he was a fellow at Brazil Network in Washington DC researching and writing on the North America Free Trade Agreement negotiations for the US Congress. He has published more than ten scholarly papers and articles on the political economy of Latin American telecom regulation.

Harry M. Trebing is Professor Emeritus (Economics) at Michigan State University and Senior Fellow at the Institute of Public Utilities, of which he was both founder and a director (1966-1992). He served as Chief Economist at the US Postal Rate Commission and US Federal Communications Commission and has been a member of various advisory panels for Congressional offices and the National Research Council/National Academy of Sciences. He was President of the Association for Evolutionary Economics, and recipient of its Veblen-Commons Award, as well as Chairman of the Transportation and Public Utilities Group – American Economic Association, receiving the Distinguished Member Award. He also served as a board member of the National Regulatory Research Institute, the Ohio State University and is currently Vice Chair of the Michigan Utility Consumer Participation Board. He is author of numerous publications and holds a PhD from the University of Wisconsin.

Gaëtan Tremblay holds a PhD from the Université Louis Pasteur, Strasbourg, France and is full Professor at the Department of Communication, Université du Québec, Montréal, where he also co-chairs a research group on communication and cultural industries in the information society (GRICIS). Concentrating on audio-visual industries and communication networks, he employs a comparative analytical approach to assess the impact of new technologies on the cultural policies of communities in Québec, Belgium, Spain, France, Brazil and Mexico. His current research focuses on the complex inter-relationship between technological change, the effects of international trade agreements such as the North America Free Trade Agreement (NAFTA), MERCOSUR and the European Union, and national policies designed to protect and foster unique cultural attributes in a diversified world.

Joseph Turow is the Robert Lewis Shayon Professor of Communication at The University of Pennsylvania's Annenberg School for Communication. He is author of 60 articles and seven books on the mass media industry. The winner of a number of conference paper and book awards, he was a Chancellor's Distinguished Lecturer at Louisiana State University during Spring 2000. He serves on the editorial boards of the *Journal of Broadcasting and Electronic Media*, *Critical Studies in Mass Communication*, *The Encyclopaedia of Advertising*, the *Sage Annual Review of Communication Research*, and *New Media and Society*. William Melody was an esteemed member of his dissertation committee.

John Ure is Director of the Telecommunications Research Project at the University of Hong Kong. His many publications on the economic, policy and regulatory aspects of telecom include *Telecommunications in Asia: Policy, Planning and Development*

(Hong Kong University Press 1995; 1997). He is section editor in L. Lievrouw and S. Livingstone (eds) *The Handbook of New Media* (Sage 2002) and joint author with P. Lovelock of the chapter 'The New Economy: Internet, Telecommunications and Electronic Commerce?' As a consultant to the International Telecommunication Union, the World Bank and telecom regulators around the region he has extensive knowledge of South East Asia. He serves on the editorial boards of the *info* and *Telecommunications Policy* journals. He also serves on the Hong Kong Government's Information Infrastructure Advisory Committee, and represents Hong Kong at international telecom forums.

Silvio Waisbord is Assistant Professor in the Department of Journalism and Mass Media at Rutgers University. He received his MA and PhD in Sociology from the University of California, San Diego. He was a fellow at the Kellogg Institute for International Studies at the University of Notre Dame, the Annenberg School for Communications at the University of Pennsylvania, the Media Studies Center at the Freedom Forum, and the Center for Critical Analysis of Contemporary Cultures at Rutgers University. His research interests are media and politics, audiovisual industries, nations and cultures, globalisation and Latin America. He is author of *Watchdog Journalism in South America: News, Accountability and Democracy* (Columbia University Press 2000) and editor, with E. Fox of *Local Politics, Global Media: Latin American Broadcasting and Policy* (University of Texas Press 2002).

Rudi Westerveld received his MSc in the Electrical Engineering Department at Delft University of Technology (TU Delft) in 1969. After graduation, he worked in the Department's particle accelerator laboratory and in 1971 joined the Teaching Laboratory Group, designing laboratory courses in measurement and electronics. From 1977 he lectured in Electronics, Instrumentation and Telecommunication at Eduardo Mondlane University in Mozambique, where he also consulted on telecom projects. In 1981, he returned to TU Delft, joining the Telecommunications and Traffic Control Systems Group in 1984 as an Assistant Professor. He supervised the TopTech MBT postgraduate telecom course and in 1994 joined the School of Systems Engineering, Policy Analysis and Management to lecture in Information and Communication Technology.
