Short description	<p>Transforming governments is both a challenge and an opportunity. Technology is increasingly becoming an integral part of transformation efforts in the public sector. While technology alone cannot achieve transformation, increasingly, transformation cannot be achieved without technology. Given this reality, governments are trying to find solutions for going about transformation in systematic, orderly, efficient and cost effective ways. Enterprise Architecture (EA) can become a useful tool for achieving these goals. More and more governments are relying on EA to guide their transformation efforts. Canada has emerged as a successful example of this approach, with its early adoption of the 'Business Transformation Enablement Program'. Many other countries have embraced the concept of EA, and their experience presents valuable lessons for developing countries. EA is no longer an esoteric technical discipline, something that is difficult to grasp, more difficult to design and even more difficult to implement. The proposed session will try to demonstrate in a nontechnical way how EA is a useful if not an essential tool for transforming governments. The session will attempt to answer the following illustrative questions: What is EA and what is the value of EA? How can governments use EA to guide decisions on transformation? Can EA help agencies to achieve greater impact and better value for money? How does one go about designing and implementing EA? What are the best practices and approaches to</p>
